as well as the League Coordinator, if provided.**

The entrant whose name appears on the entry form agrees that CT State USBC Association, its officers and agents shall be liable only to the extent of returning the entry fee. If and when the entrant shall have been prevented from bowling in the tournament, which may be brought about by war, national emergency or causes relating thereto or resulting from fire, strikes, lockouts, labor difficulties or other causes beyond the control of the CT State USBC Association.

2022 CT State USBC Association Youth / Adult Tournament

- 1.) The Tournament shall be USBC Certified and governed by USBC rules and regulations except as hereinafter set forth.
- 2.) **ELIGIBILITY:** All adult entrants must be a CT State USBC Association member for the current season at least thirty (30) days prior to first event bowled. All youth entrants must be certified USBC Youth members at least fifteen (15) days prior to first event bowled and bowling in a Connecticut Youth program during the 2022-2023 season. No unattached membership will be available at the tournament site.
- 3.) **FORMAT:** This shall be a **Handicap** based tournament. Handicap shall be calculated based upon 90% of the difference between a bowler's USBC average and 240. **There will be no maximum handicap.** The Tournament format is as follows:
 - I. **Team** – Teams shall consist of one (1) Adult bowler and one (1) Youth bowler.
 - a. Bowlers may enter multiple times, however, only the highest placement shall be awarded with the same partner.
 - b. All teams shall bowl three (3) games on their assigned pair of lanes.
 - II. **Divisions** – Divisions shall be based upon **Team Average** as follows:
 1. **Handicap 'A'** – Team Average 371 & Over
 2. **Handicap 'B'** – Team Average 341 to 370
 3. **Handicap 'C'** – Team Average 301 to 340
 4. **Handicap 'D'** – Team Average 300 & Under
 - b. In the event a division does not have enough entries the tournament director may combine divisions as needed.
- 4.) **AVERAGES:** Averages used for calculating handicap shall be determined as follows (in this order):
 - a. Highest sanctioned average from the 2021 - 2022 season with a minimum of 21 games bowled.
 - b. Highest sanctioned average from the 2020 - 2021 season with a minimum of 21 games bowled.
 - c. Highest 2022 summer league average with a minimum of 21 games bowled. **(AVERAGE/LEAGUE SHEET REQUIRED)**
 - d. Highest USBC sanctioned average from the current 2022 - 2023 Season with a minimum of 21 games bowled as of November 12, 2022. **(AVERAGE/LEAGUE SHEET REQUIRED)**
 - e. If no verifiable average, the bowler shall bowl **scratch**. The Tournament Manager has the right to adjust averages based on Sport, Challenge, or Standard/House averages according to USBC Rules 201 (a-c).
- 5.) **ENTRY FEE:** The entry fee per Team (\$40.00) shall be as follows:

 - a. Walk-In entries shall be permitted based upon lane availability. **All Walk-In entrants must report for check-in one (1) hour prior to the scheduled squad time and entry fee must be paid in CASH.**
 - b. No refund of entry fee will be made after entry has been processed and squad time assigned. Entry fee must accompany entry form. All checks should be made payable to: **CT State USBCA.** (Returned checks and any check fees must be paid in cash, bank check, or money order prior to bowling.)
- 6.) **SCHOLARSHIPS:** Scholarships shall be awarded as follows:
 - a. All Scholarships shall be awarded to the Youth bowler only and administered through the USBC SMART program.
 - b. Additional scholarship money added from CT State USBC Association funds.
 - c. Scholarships will be awarded on a ratio of at least one (1) for every eight (8) entries or major fraction thereof in each division.
- 7.) **AWARDS:** Special awards shall be as follows: (No cash prizes shall be awarded)
 - a. Championship awards will be presented to the First Place winners in each division. All First Place champions will be invited to the CT State USBC Annual Youthfest.
 - b. In the event of ties for First Place, co-champions will be declared and duplicate awards will be given.
- 8.) **CHECK-IN:** All participants must check-in with Tournament Officials at least thirty (30) minutes prior to squad time.
 - a. Substitutions must be submitted to Tournament Officials **at least one (1) hour prior** to the scheduled squad time.
 - b. All participants **must** present their membership card at check in. **If not available, current membership receipt is required.**
- 9.) **DRESS CODE:** All participants must wear appropriate tournament attire for all ages.
 - a. Competitors shall provide their own bowling shirt (with finished sleeves) with a butterfly collar or mock collar. Mock collar must be one inch up on the neck. T-shirts promoting either a league, bowling center or bowling equipment are permitted. Appropriate shorts, skirts, and skorts (mid-thigh) will be permitted. Gym shorts, short shorts, basketball type shorts, sweat pants, and leggings are **NOT** permitted. Jeans (no holes) are allowed. Head covering (hats, caps, bandannas, etc.) or sunglasses are NOT allowed. A Tournament Official must approve any exceptions prior to the event.
- 10.) **ELECTRONIC DEVICES:** Use of electronic devices shall be as follows:
 - a. Headphones, cell phones, iPods, etc. may **only be used in the settee area.** They may not be used while bowling nor cause a delay of game. If either occurs, a warning will be issued at the discretion of a Tournament Official followed by forfeiture of frames and/or games if necessary, per USBC Rule 11.
- 11.) **ADDITIONAL RULES:**
 - a. No smoking or consumption of alcoholic beverages will be allowed while participating in the tournament. Any violations shall be subject to disqualification by Tournament Officials.
 - b. Entrants shall not be permitted to leave the bowling settee area without permission of a Tournament Official.
 - c. Appeals and Protests shall be governed under USBC Rule 329.
- 12.) The Tournament Manager shall have the authority to decide upon matters not covered by the aforementioned rules.
